

Mirfield Show - Call for Catering Tenders: 2024 and 2025 Inclusive

Mirfield Show is a highly popular event in the area and regularly attracts thousands of people. We have also won a Local Award for the best event in the area. We are now in the process of gathering Bids (i.e. the fee you are willing to pay us, per year) from caterers wishing to hold a food concession at the show.

If accepted, you would be guaranteed a place at the show for BOTH August 2024 and 2025 – the same fee applying in both years. Please note that competition for places is fierce!

We are looking for 9 concessions to provide a “food court” (where we will provide seating) PLUS we require a “Barista Coffee” and a “Slush” concession (these concessions will be positioned elsewhere on the field). The minimum bid for the food concessions is £400, the minimum bid for the Coffee and Slush is £300.

We are looking for the Food Concessions to set up on the Saturday between 10am and 9pm. If you are not able to do so please advise why. We will be undertaking safety checks and all T&C's must be adhered to.

This is very much a family event with lots of children attending. We are very keen that the catering offered gives good value-for-money, and so the prices you intend to charge will play an important part in our decision. Further, we require your prices to remain the SAME in both years. We will photograph and monitor your prices.

You may offer us more than one type of concession but please make a bid for **EACH ONE**. The criteria used by the Committee to select successful applicants are:

- a) The amount of your bid;
- b) Prices of your product to the public;
- c) Attractiveness of your vehicle / stall;
- c) Our need to offer a variety of food types at the show.

To send in a tender please use the address below. **YOU MUST INCLUDE** the following as part of your tender:

1. Your menu of items together with confirmed prices to be charged;
2. Details of site requirements (please specify LEFT or RIGHT opening);
3. Dimensions of space, including height if relevant (INCLUDING towbar);
4. Photograph (s) of your stall/vehicle (ABSOLUTELY REQUIRED);
5. Details of 2 OTHER events you attended in the last 12 months;
6. Certificate of valid Public Liability insurance and your Food Hygiene Certificate;
7. A declaration that you have read and accepted our TERMS AND CONDITIONS (enclosed).
8. Details of any generator you will use (**DIESEL ONLY - Petrol Generators are not permitted**)
9. Details of any other source of heat (**LPG**) and method of ensuring it is tamperproof.
10. Types of Fire extinguishers you have (Dry Powder, AFFF, Wet Chemical, Carbon Dioxide, Fire Blanket).
11. How will you dispose of waste materials? (**Rubbish must not be left by your concession**)

We are looking to confirm contracts by mid February so your tender must be IN OUR HANDS no later than 31st January 2024.
